

José Luis Irigoyen

Mr. Irigoyen has more than 30 years of professional experience working on development issues in the field of transport. He brings passion, strategic leadership and a deep understanding of sectoral trends and cross cutting issues such as climate change, gender, governance and disruptive technologies to the global debate on sustainable development, and has a track record building partnerships and achieving impact on the ground. He was Senior Director of the Transport Global Practice of the World Bank when he retired from the World Bank in November 2018. Established in 2014, the Global Practice included Transport and Information and Communication Technologies (ICT) until July 2018. Mr. Irigoyen oversaw a portfolio of about 200 projects and US\$40 billion in lending commitments in more than 80 developing countries. Previously, Mr. Irigoyen was a Director under the Sustainable Development Network responsible for policy advice on transport, water, ICT and infrastructure financing between 2010-2014, and a Senior Manager in the Africa Region between 2008 and 2010. He joined the Bank in 1990 in the Latin America and Caribbean Region, where he held positions of increasing responsibilities including that of Transport Sector Manager between 2001 and 2008. He pioneered work on public-private partnerships in concessions and performance-based contracts in the Latin America and Caribbean Region and was the Head of the Global Expert Team for Public-Private Partnerships between 2010-2014. Before joining the World Bank he worked as a transport consultant with extensive experience in the Latin America region, including assignments in Argentina, Chile, Costa Rica, Dominican Republic, Paraguay and Peru. Mr. Irigoyen has been a frequent speaker and panelist at international events hosted by the International Road Federation, International Transport Forum, Korea's Transport Institute, PIARC, Transportation Research Board, United Nations and the World Resources Institute. He was a keynote speaker at the 2016 World Conference on Transport Research in Shanghai and was a member of the Steering Committee of the WCTR Society between 2016-2020. An Argentine national, Mr. Irigoyen graduated in 1977 as a Civil Engineer with a specialization in Transport from the University of Buenos Aires.
